# Paolo Bonanni

He is graduated in Medicine and Surgery (MD) in 1985 and got two specializations in Hygiene and Preventive Medicine at the University of Genoa, Italy. From 1992 to 2000 he was Associate Professor, and since 2000 he is Full Professor of Hygiene in the Faculty of Medicine, University of Florence, Italy. He has been a member of the National Vaccination Commission of the Italian Ministry of Health, and he acts as an expert consultant for the European Centre for Disease Prevention and Control (ECDC). He is standing adviser of the Viral Hepatitis Prevention Board (VHPB). He is also member of the European Technical Advisory Group of Experts (ETAGE) at the World Health Organization, on vaccine-related scientific and technical issues. Paolo Bonanni is the Director of the University of Florence Post-Graduate Course on 'Vaccines and Vaccination Strategies', established in 2001, 18 editions of which have been followed by over 700 Italian MDs.


# **Martin Seychell**
